Rector - Canonical Role

- Lead worship & spiritual life
- Select and oversee assisting clergy
- Use and control of all buildings
- Education on doctrine & discipline
- Stewardship education
- Sacramental preparation

Vestry – Canonical Role (3yr)

- Legal representatives of the congregation in all financial matters
- Ensure standard Business methods are observed
- Nominating people for Holy Orders

In the absence of a Rector

- Continuation of worship
- Calling of a rector

Joyfully seeking and serving Christ

- Regular attendance at worship
- Regular attendance at Vestry Meetings
- Regular attendance at Parish Events
- Pray for the Rector & Parish
- Lead as stewards with Time, Talent, Treasure
- Liaison to one of the 5 C's or other key ministries
- Complete Safeguarding Courses

- Identify and support new leaders
- Ongoing discernment of God's call
- Share the Good News beyond the walls
- Listen to other parishioners and share concerns where appropriate
- Active ministers of the Gospel in daily life and work
- Risk openness with ideas, beliefs and desires.

Wardens-Canonical Role (2yr)

- Member of Vestry
- Must be Confirmed
- Duties more defined in absence of Rector
- Junior versus Senior at St Luke's
- Not and employee/employer relationship with Rector (Warden is not the "boss")

Warden - Expectation

- Lead by example on with vestry responsibilities and hopes.
- Lead in supporting the Vision and Mission
- Advisor, encourager, a supporter, and a confidante to Rector
- Provide candid feedback to Rector
- Check Signing/Voucher Approval
- Concern for well being of Rector

- Function as communication link with diocese
- Convene and preside at vestry meetings
- Make provisions for Sunday Worship
- Take administrative responsibility for property
- Act as custodian of parish records

- Attend Diocesan Convention Pre-Meeting
- Review Convention Materials
- Attend Diocesan Convention

Memorial Committee

The Memorial Trust shall be administered by a Committee of three members, one elected by a Parish Meeting to serve for a three-year term, the Treasurer and a chair that shall serve at the Rector's pleasure. The Committee shall keep a written account of the Memorial and a record of its actions.

Memorial Committee

The Memorial Committee may choose to release up to one-half of the gifts received and income earned in each year for community, social ministry or outreach programs. The Vestry or any Committee appointed by the Vestry for that purpose shall grant these funds for these intentions.

Foundation Committee

The Foundation shall be administered by a Committee of five members, of whom two shall be elected by a Parish meeting to serve for three-year terms, a chair who shall serve at the Vestry's pleasure, the Treasurer and the Senior Warden.

Foundation Committee

The Foundation Committee may choose to release up to one-half of the income earned in each year, but none of the principal, to the Vestry for a non-recurring items of repair, upkeep or reconstruction of Parish buildings that has an aggregate cost of at least \$2,000.

Foundation Committee

At any time the Foundation has accumulated over \$150,000 of principal and income earned, a duly constituted Parish Meeting, may by a vote of the greater of two thirds of the votes cast or thirty votes, distribute not more than 50% of the existing principal balance of the Foundation






